Our Performance Programs enable dancers to soar to new heights! Participating in a Performance Program is a fantastic opportunity to further engage in dance training and gain experience on stage, while making new friends and having fun.

In 2027, Bayside Dance will offer three different performance team opportunities, each designed to suit dancers with different needs:

- Mini Troupe - for 4-6 year olds (e.g. Pre-Prep/Kindy to Year One)
- Performance Teams - for Level 2 (aged 7 at 01/01/2027) and above
- Talent Development Program - for highly dedicated students in Level 5 and above

MINI TROUPE

For dancers aged 4-6 years who love dancing and want to explore getting on stage!

A fun introduction to the world of performing for your little budding superstar!

Mini Troupe Package includes:

- Rehearsal once/week
- Learning two or more routines
- Costume hire
- Team shirt
- Two competitions, community performances, concerts
- All competition entry fees
- Break up party and other fun activities

Requirements

Minimum one class/week at Bayside Dance in 2027

Entry by application

Rehearsals will be once weekly, approx 45 mins-1 hour

Investment: \$380 in Term 1, \$195 in Term 2 and \$185 in Term 3 (no charge in Term 4)

(Note that this package is in addition to the minimum weekly class)



PERFORMANCE TEAMS

Designed for dancers who love to dance and who want to get experience on stage while having fun, making friends, and learning new skills!

Includes

- Rehearsal once/week
- Learning two or more routines
- Costume hire
- Team shirt
- Minimum two competitions, performance teams showcase, community performances, concert
- All competition entry fees
- Break up party and other fun activities
- Performance teams are grouped by age and/or Level

Requirements

Minimum two classes/week at Bayside Dance in 2027
Entry by application

Investment: \$380 in Term 1, \$290 in Term 2 and \$290 in Term 3 (no charge in term 4)

(Note that this package is in addition to the minimum weekly classes)



TALENT DEVELOPMENT PROGRAM

Designed for dancers seeking an exceptional dance experience, with additional coaching, multiple performance opportunities and a high calibre of technical tuition. Drawing from the latest academic research in talent development in dance, this program is designed for dancers who are seeking specialised training in order to propel them towards future full-time dance training and a professional dance career. In 2027, we will offer two Talent Development Program teams - Rise and Signature. Dancers will be placed in the team that best suits their development (includes age, training history, skill and development).

Includes

- Two rehearsals/week (pending timetabling and class size)
- All of the Performance Team inclusions (t-shirt, comp entry fees, costume hire)
- Team bootcamp in January
- Weekly flexibility & conditioning class
- Weekly Leaps, Kicks and Turns class
- Up to three competitions, performance teams showcase, community performances, concert
- Your choice of a weekly private lesson OR ballet extension class
- Talent Development Program Package is an "all in one" package, inclusive of the minimum three classes/week

Requirements

- Minimum 3 classes/week in 2027, one of which must be ballet
- Entry by application, audition and interview
- Due to the elite level of participation and number of hours of training per week, TDP dancers are not permitted to participate in dance tuition outside of Bayside Dance without prior approval (school dance excluded)

Investment: \$1815 Term 1; \$1615 Term 2 and 3; \$1415 Term 4 #

#Includes TDP package, flexibility & conditioning class, Leaps, Kicks and Turns class, three weekly classes (one of which must be ballet), and either private or extension class. Discounts apply for any additional classes enrolled in over and above the minimum.

When are auditions/interviews for the Talent Development Program?

We will advise an audition and interview date in Term 4 2026.

Dancers unable to make the audition may submit a video audition and response to interview questions. .

Can I put my name down for the Talent Development Program and Performance Troupe in case I'm not accepted into TDP this year?

Yes, there's an option for this on the EOI form.



When will I find out if I'm accepted and what will I then have to do?

We'll be announcing our teams prior to our office closing for the year in December. You'll be asked to complete a contract agreeing to our terms and conditions and to pay a non-refundable \$60 deposit to hold your place.

What is the difference between TDP and Performance Teams?

We strive to cater for all the different types of dancers we have here at Bayside Dance. We want all our dancers to succeed and reach their goals, no matter what they are! TDP is designed for dancers interested in making commitments to their dancing, whereas performance teams are more about gaining experience and improving skills.



When will rehearsals be?

Great question! We're still creating our 2027 timetable so will confirm this toward the end of the year.

Why are the packages front-loaded?

This was in response to parent feedback and is designed to ease pressure on families. Rehearsals and team participation will still continue in Term 4.
